POLL RESULTS OF ANNUAL GENERAL MEETING

Reference is made to the circular dated 20th April 2017 (the “Circular”) and the notice of annual general meeting (the “AGM Notice”) issued by First Shanghai Investments Limited (the “Company”). Terms used in this announcement shall have the same meaning as defined in the Circular unless the context requires otherwise.

At the AGM of the Company held on 26th May 2017, a poll was demanded by the Chairman for voting on all proposed resolutions.

As at the date of the AGM, the number of issued shares of the Company was 1,418,973,012 shares, which was the total number of shares entitling the holders to attend and vote for or against all resolutions at the AGM. There were no restrictions on any shareholders to cast votes on any of the proposed resolutions at the AGM.
